Open Learning courses

Online exchanges and training have gained more and more importance during the COVID-19 pandemic. To support its members all across Europe, the European Association of Hospital Pharmacists (EAHP) initiated the creation of an open learning environment in spring 2018. Since then 10 different open learning courses have been added ranging from 1.5 hour training on specific topics to 5 hour in-depth courses.

Hospital pharmacists and other interested healthcare professionals can choose from the following courses:

- Therapeutic Drug Monitoring as a Tool for Therapy Optimisation

Optimal care for the management of older people with frailty non-weight bearing after lower limb fracture: a consensus study



An online consensus survey to define the optimal care for older people with frailty who are non-weight bearing after a lower limb fracture has been launched. This study is led by Professor John Gladman (Division of Rehabilitation, Ageing and Wellbeing, Medical School, University of Nottingham), funded by the NIHR Nottingham Biomedical Research Centre, and has obtained research ethics approval from the Faculty of Medicine and Health Sciences Research Ethics Committee/ Nottingham University (FMHS REC ref no 423-1911).

Healthcare professionals, including hospital pharmacists, are encouraged to participate in the study. The online survey is conducted in the form of a Delphi study, meaning there will be three rounds. In each round, participants will be asked to rate their agreement with a series of statements by marking 'agree' or 'disagree' and a box for free-text comments will be provided to suggest amendments or clarifications to the statements. It will take you around 20-30 minutes to complete statements in each round.

Evaluation of orphan and paediatric medicines legislation



In mid-August, the European Commission shared its evaluation of the Regulations on medicinal products for paediatric use and on orphan medicinal products. The review of both legislative instruments concluded that they had fostered the development and availability of medicines for children and patients with rare diseases. However, despite the increase in treatment options for these patient groups, the findings also highlighted different shortcomings.

Although more patients are benefiting and the number of clinical trials for children increased the positive impact of both Regulations is not reaching everyone. Developments are lacking, in particular, in areas with the greatest therapeutic need and not all patients across the EU have equal access to the medicines marketed due to the Paediatric and the Orphan Regulation. As a next step, the European Commission is working on a preliminary impact assessment that will be released in autumn.

To inform policy and practice development of patient and medication

safety initiatives the International Pharmaceutical Federation (FIP) has put together a reference document. Titled 'The Pharmacists' role in "Medication without harm", the reference document provides information about what pharmacists can do to promote patient safety at an individual patient level as well as at organisational levels.

The document shares insights on patient safety practices in Australia, Canada, Finland, India, Oman, Saudi Arabia, South Africa, the Netherlands and the USA. Besides, it outlines how Europe is improving polypharmacy, offers information on pharmacists' value in collaborative healthcare teams and discusses some of the potential key risks to patient safety during the different stages of the medicines use process.
