During last year’s virtual congress, we focused on digitalization and automation to improve future patient care. I suppose that these new technologies found their way in to your daily practice or at least gave you inspiration for new projects. But these changes go beyond the hospital pharmacy and even beyond the hospital and healthcare; the whole world is evolving quickly which results in new needs and expectations from society. This year we will help you to determine and to explore the changing roles of hospital pharmacists in this evolving scene. This is an invitation to all of you to join us.

The 26th EAHP Congress will offer you inspiration to prepare for this changing world and how to embrace the opportunities to guarantee optimal patient care within the available resources. Based on the success of last year’s congress, the Synergy programme is extended and will continue with many relevant topics.
